

## Merriwood Christian Camp Scholarship Application

1. All requests for assistance should be made on this MCC Scholarship Application form.
2. All Scholarship Applications should be mailed to Merriwood Christian Camp, Scholarship Department, 9640 Center Grove Church Rd., Clemmons, NC 27012.
3. In order to register for a scholarship, MCC must receive your fully completed scholarship application, registration form, and \$50 deposit. (If you prefer to defer paying the \$50 deposit until you learn what Merriwood may be able to scholarship, please check the appropriate box, indicating this, on the bottom of 2<sup>nd</sup> page). However, please note that a child is not registered for a week of camp (i.e. a space is not reserved for a week of camp) until the \$50 deposit has been received. Spaces fill up quickly in the summer camp sessions. We are unable to hold a space in a particular week until we have the registration form and \$50 deposit in hand. MCC will notify you as to what portion of the fee we **may** be able to assist with, as soon as possible.
4. A limited amount of scholarship funds are available for campers with financial needs. MCC requires all campers to pay a minimum of the \$50 non-refundable, non-transferable deposit no matter what the scholarship amount may be. Generally, qualifying applicants are awarded between 15-50% of the total camp rate, with 50% of the total camp rate being the maximum Merriwood awards.
5. For those receiving scholarships, MCC will only provide financial assistance for one program per camper per summer season. If you desire to sign up the camper for additional sessions, they must be paid for in full.
6. All remaining summer camp balances are due 60 days before the start of the camp session.
7. If you are part of a church, we first recommend you contact your church to see what assistance they may be able to provide as well.
